



# **4 BALL LADIES MATCHPLAY**

**Qualifying Round\*: Wednesday, 11 June 2025 (PM)**

**1<sup>st</sup> Round: Tuesday, 17 June 2025 (PM)**

**2<sup>nd</sup> Round: Wednesday, 18 June 2025 (PM)**

**Final Round: Friday, 20 June 2025 (AM)**

### **Terms of Competition (TOC)**

1. The 4-Ball Ladies Matchplay Competition is open to members with WHS Handicap Index 24.4 & below.
2. Two players to form a team and the combined WHS Handicap Index of any pair should not exceed 40. Players shall play off 90% of their Course Handicap.
3. There shall be 8 pairs of competitors for this Ladies 4- Ball Matchplay.
  - A. Should there be fewer than 8 pairs, the competition shall be cancelled.
  - B. Should there be more than 8 pairs of entries received, an 18-hole Qualifying Round will be held on Tuesday, 11 June 2025 at Tampines Course.
  - C. The top 8 pairs with the lowest 4-Ball nett score from the qualifying round will qualify for the Ladies 4-Ball Matchplay.
4. If one player withdraws from the competition after the draw has been determined, there shall be no replacement and her partner shall represent the pair in the stipulated match.

**One-time Entry Fee: \$21.80 / Buggy Fee Per Round: \$34.88**

*All fees are per participant and inclusive of 9% GST*

**Registration opens Wednesday, 28 May 2025.**

**Registration closes on Monday, 2 June 2025 at 5pm.**

**All cancellations must be made by Wednesday, 4 June 2025 at 5pm.**

Full entry is chargeable for late cancellations.

**Inclement Weather:**

In the event of inclement weather not permitting the completion of 18 holes, the number of completed holes (minimum 9 holes) shall be used to determine the qualifiers. Should inclement weather affect the entire session, the 8 pairs of qualifiers shall be determined by the lowest combined team handicap index.

**Matchplay Proper:**

In the event of inclement weather not permitting the completion of all the matches, the results of completed matches will stand. For incomplete matches or completed matches which resulted in a tie, the players shall complete their match prior to the commencement of the subsequent round, on the following dates provisioned for completion of incomplete/ tied matches.

If a match finishes all square, play shall continue until a hole is won, starting with the 1st hole.
